

**2009 QUILTERS UNLIMITED QUILT SHOW POSTER CONTEST
RULES AND ENTRY FORM**

- 1. Entrants may use markers, colored pencils, crayons, paints or other single-dimensional mediums/products, as well as mechanically produced art or copies. ALL DESIGNS MUST BE YOUR OWN ORIGINAL WORK.**
- 2. Please submit BOTH a color copy suitable for a poster (11" by 17") and a black/ grayscale on white copy suitable for the show program cover (8 ½ " by 11") with a signed entry form.**
- 3. Your name, address, phone and email address (if you have one) MUST be clearly on the back of EACH and EVERY design sheet submitted, not just on the envelope or just one of the entries. Be careful that the ink does not bleed through to the front.**
- 4. Designs must include the following wording (a) 36th Annual Quilters Unlimited Quilt Show (b) May 15-17, 2009 (c) Dulles Expo Center Chantilly, Virginia (d) the quilt show theme you've chosen. If you choose you may incorporate your name/ signature, business name and website. This must be done in a way that does not distract from the message of the poster.**
- 5. The design should be able to be duplicated for publicity materials and other uses that support the mission of Quilters Unlimited, including, but not limited to, increasing attendance at the 2009 QU show.**
- 6. All entries must be postmarked no later than May 1, 2008. Mail a print of your designs with a signed entry form to Quilters Unlimited 2009 Poster Contest, c/o Diane Kirkhart, 1452 Carrington Ridge Lane, Vienna, Virginia, 22182-1755. Designs will not be returned. Quilters Unlimited is not accepting any internet entries.**
- 7. DO NOT SEND THE ONLY COPY OF THE DESIGN. All designs submitted should be photocopies or any other clear, non-smudging reproduction. DO NOT FOLD OR BEND THE COPY.**
- 8. A PRIZE OF \$100 will be awarded to the winner.**
- 9. QU will select "semi-finalist" entries. Each of these entries will be displayed at the 35th Annual Quilters Unlimited Quilt Show, June 6 – 8, 2008 at the Dulles Expo Center in Chantilly, Virginia. Anyone attending the show will be given a ballot to select the People's Choice Winner. Voting will close at 3:00 on Sunday, June 8, 2008. At 3:30, the 2009 poster contest winner will be announced at the show. The semi-finalist with the most votes will be the 2009 Poster Contest Winner. Additionally, the winning poster design will be announced at quiltersunlimited.org**
- 10. If you are the winner, you will be asked to send the original artwork to QU. Upon receipt of original work, QU will award the \$100 prize to the winner plus reimburse postage expenses.**

11. All entries and materials submitted to QU in connection with the contest (collectively, "Entry Materials"), along with all copyright, trademark and other proprietary rights associated therewith, become the property of QU upon submission. Additionally, QU grants to you a non-exclusive, royalty-free world-wide license to use the Entry Materials for self promotion purposes only. You may not sell, sublicense or distribute the Entry Materials.

12. You hereby warrant that (a) you own all rights to all the Entry Materials submitted by you, and (b) all such Entry Materials are original works of authorship on your part and have not been copied, in whole or in part, from any other work and do not violate, misappropriate or infringe any copyright, trademark or other proprietary right of any other person or entity.
